




#### FIGURE 1. AGE DISTRIBUTION OF LATINOS IN IL SENATE DISTRICT 2








#### FIGURE 1. AGE DISTRIBUTION OF LATINOS IN IL SENATE DISTRICT 3 $\,$






#### FIGURE 1. AGE DISTRIBUTION OF LATINOS IN IL SENATE DISTRICT 5 80-85 YEARS



LATINOS AS A PERCENTAGE OF TOTAL POPULATION PER DISTRICT













### FIGURE 1. AGE DISTRIBUTION OF LATINOS IN IL SENATE DISTRICT 37 80-85 YEARS






### FIGURE 1. AGE DISTRIBUTION OF LATINOS IN IL SENATE DISTRICT 39






### FIGURE 1. AGE DISTRIBUTION OF LATINOS IN IL SENATE DISTRICT 41






### FIGURE 1. AGE DISTRIBUTION OF LATINOS IN IL SENATE DISTRICT 45 80-85 YEARS
